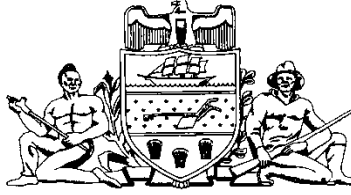

CJAB Fact – **Highlight Second Chance Month & Reentry Week!**– In 2012, Probation & Parole had more than 7,000 people under active supervision, with often more than 100 individuals per caseload, per officer, and overall criminal docket numbers soaring. CJAB members began what became a decade-long review of practices of the entire criminal justice system, specifically focusing on screenings and assessments. Evidence informed strategies were implemented with a focus on Probation & Parole practices. As of 2022, along with important **diversionary initiatives** and population specific work like Stepping-Up, there have been significant reductions in Probation & Parole caseloads (31%), new arrests while under supervision (15%), technical violations (25%), and a reduction in Revocation Hearings (15%).
