The following is an overview only. It highlights processes we have in place that deliberately address a treatment related need and focus on diversion from the system. This does not include direct federal JAG Awards to Police

departments. Did not include the Arnold Prosecution & Equity Research Award. Accelerated Rehabilitative Disposition (ARD) and weekly Bail Review Team meetings for diversion. All of these are not included as they are not explicitly focused on individuals who have a treatment need.
