Offices to be filed by Nomination Certificate

Pursuant to Title 25, Section 2953 and 2954 of the Pennsylvania Election Code in all cases where a vacancy shall occur for any cause in an elective public office, including that of judge of a court of record, at a time when such vacancy is required by the provisions of the Constitution or the laws of this Commonwealth to be filled at the ensuing election but at a time when nominations for such office cannot be made under any other provision of this act, nominations to fill such vacancies shall be made by political parties in accordance with party rules relating to the filling of vacancies by means of nomination certificates and by political bodies by means of nomination papers.

The offices listed below are to be filled by nomination certificate or nomination paper and will appear on the November 4, 2025 Municipal Election (these positions do not appear on the municipal primary ballot as the vacancy occurred after the deadline).
